Re: Illegalities with respect to administration of IRPS (2)

Dear Shri Kapil Sibalji,

On March 26, 2008 we had already conveyed to this Ministry various grave irregularities in IPRS (see the Memorandum herewith attached). We wish now to draw your attention to a new, very grave development.

It is well-known that the Indian Performing Right Society (IPRS) has accumulated undistributed royalties estimated at around 25 crores rupees which it has invested in various bonds and fixed deposits, these royalties belong mostly to authors-composers who have not been paid their royalties because they refuse to sign the Society's Compulsory Letter wherein they are made to surrender their all rights to the Publishers accept the New 2008 Memorandum and Articles of Association which removes them from any executive position in the Society.

While IPRS makes royalties payments only twice a year - in February - March and in September- October- highly reliable sources within the music industry have informed us the Society has started issuing in the last two weeks very large, outof-turn cheques to some record labels/ publishers; this timing follows the tabling in Parliament of Standing Parliamentary Committee's Report on your Copyright Bill Amendments 2010.

We wish to convey to you our strong apprehension that the present management of IPRS, anticipating the changes that our Amendments will bring to the Society, has decided to distribute to Publishers all royalties in its accounts so that the future management of the Society will inherit an empty shell.

Given the gravity and urgency of the matter, we, the undersigned, humbly request you to exercise the powers conferred to you under Section 33 (5) of the Act – and recommended by the Parliamentary Report in clause 16.13- by appointing an administrator to discharge the functions of the Society.

Dear Sir.

We the undersigned Artistes write to bring to your attention certain facts in relation to the Indian performing Right Society Limited, known as the IPRS

All the undersigned Artistes are members of the IPRS having assigned their copyrights in literary and musical works to IPRS by signing individual assignment deeds in favour of IPRS.

As part of the terms of the assignment deeds IPRS is obligated to collect royalties from the Public Performance / Communication to the Public in relation to the literary & musical works assigned to IPRS by its members, deduct its administrative expenses as mandated by the Act and distribute the remaining amounts as per the MOU of 1993.

IPRS Obligation to Pay Royalties to Members:

The MOU of 1993 between IPRS and Music Companies through the Music Company association the IPI mandated that the royalties collected by IPRS would be distributed in the following ratio:

- a. 50% to the Music Publisher which is the Music Company since Music Companies claimed to be the assignees of Film Producers;
- b. 30% to the Music Director or Composer
- c. 20% to the Author or Lyricist

The assignment agreements executed between Music Company members and IPRS as also the agreements executed between Authors and Composers with IPRS all contained even today the obligation of IPRS to ensure that the royalties collected in relation to the members works are distributed in the above mentioned ratio. None of these agreements save the agreements with T-Series have been terminated and so the contractual and legal obligation of IPRS to pay royalties as per the 1993 MOU continues.

Transfer by IPRS of members rights to third parties

Sometime in 2004, IPRS inexplicably and certainly at the behest of its Music Company members decided to terminate existing mobile distribution agreements executed with third party aggregators. It was discovered much later that the said rights of communication to the public and distribution were in fact handed over completely without sanction of the author or composer members to the Phonographic Performance Limited or PPL as it is referred to normally and / or the Indian Music Industry or IMI which the association of the Music Companies. Copies of three such letters informing the licensees of IPRS of this 'transfer' of rights are enclosed for your information and action.

Sir, this whole sale transfer of rights has not stopped here but also extends to TV Broadcasting rights where IPRS has authorized one Select Media Holdings Ltd., who is stated to be the 'licensee' of both IPRS and PPL.

The exercise of TV Broadcasting related licensing activities by the said Select Media Holdings Ltd. is both contrary to Section 33 of the Copyright Act and also violative of the terms of registration of IPRS and PPL.

Non-Payment by IPRS of Royalties to Author/ composer members

When the undersigned Artistes sought to protest the acts of certain music company members of IPRS who were inclined to transfer rights out of IPRS, the IPRS started to demand the

Artiste members of IPRS sign letters stating that they did not own any copyrights. The IPRS in fact made this a condition for the author composer members to receive their royalty which IPRS was in fact bound to pay as per the terms of the individual assignments agreements and more so by virtue of the 1993 MOU.

When the undersigned artistes refused to execute the above mentioned letters, IPRS declined to pay the members their royalties. The fact is that IPRS has since then refused to pay royalties to the undersigned members if they do not execute the stated letters agreeing that they do not retain any copyrights.

<u>Author/ Composer members - Downgraded membership</u> status:

The situation has deteriorated to such and extent that in the intervening period since 2005, IPRS has at the behest of the Music Company members now classified authors and composers as "Ordinary Members" while Music Companies are classified as "Owner Members".

The action of the music company members of IPRS which violate the law of the land also have contributed to IPRS suffering a serious loss of credibility among large sections of licensees, the Government and even the Judiciary. Even the Parliamentary Department Related Standing Committee- HRD has taken note of the occurrences within IPRS and the report of the Committee is replete with scathing comments disapproving of the acts of the Societies.

Sir, we urge and request you to take immediate steps to bring IPRS to book as well as ensure that IPRS complies with the law.

Given the situation, we therefore urge that the Government take steps to appoint an administrator to oversee the functioning of IPRS and ensure that all members of IPRS are treated fairly.
