(ii) The Board is having a library which is having the legal books pertaining to Intellectual Property Law, rule books relating to administration and accounts etc. Due to paucity of space, one portion of the library room is used for keeping case files.

Presently 19 Computers, 18 printers, 1 server, 2 photo copier machines and 1 franking machines are provided.

(iii) During official sittings at places other than Chennai a Conference Hall is provided for the conduct of hearing. Further a car for each Member is provided to reach the venue of hearing. A room is provided for the Hon'ble Members at the venue for use. The conference room for conduct of hearing is provided by Patent Office at Delhi, Mumbai and Kolkata . For Ahmedabad, the court room for conduct of hearing is being provided by High Court of Gujarat. Regarding stay of Hon'ble Chairman, Vice-Chairman and Technical Members, they stay at Government Guest House or Private Hotels as per the availability for which they are expected to pay the rent and claim the same from the Government under the T.A. Rules.
